



NOTE

1. Number of students for each course was based on approximation. There may be more or less students in each case.
2. Lecturers/invigilators are urged to be punctual and regular to examination schedules.
3. Course lecturers on duty are expected to be present from the first paper till end of final paper of the day.
4. Check-in formalities for Students shall commence at least 30 minutes to the examination time.
5. Students shall not enter the examination halls with suits/jackets, cell phones, any electronic devices/unauthorized aids, etc.
